RESOLUTION NO. 2019-04

RESOLUTION ADOPTING A TOWN TRANSPORTATION PLAN PURSUANT TO THE REBUILD ALABAMA ACT

WHEREAS, the Alabama legislature in Act. No. 2019-2 adopted the Rebuild Alabama Act; and

WHEREAS, the Rebuild Alabama Act provides for an allocation among the municipalities of the state on the basis of the ratio of population of each municipality to the total population of all municipalities of the state a portion of the additional taxes levied under the Act to be used for transportation infrastructure, improvement, preservation and maintenance; and

WHEREAS, the Act provides that the municipal governing body of the Town of Mulga, Alabama shall adopt an annual Transportation Plan no later than August 31, which shall provide a detailed list of projects for which expenditures are intended to be made in the next fiscal year and shall be based upon an estimate of the revenues anticipated from the fund in which the additional revenue is deposited during the next fiscal year; and

WHEREAS, the Act further provides that any such funds shall be used only for the maintenance, improvement, replacement, and construction of roads and bridges maintained by the Town of Mulga, Alabama and such other uses as are defined in the Act.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Mulga, Alabama while in regular session on Wednesday, September 3. 2019 at 6 pm as follows:

1. The Town Council of the Town of Mulga, Alabama hereby passes this Resolution to ratify and to stand as its Transportation Plan submitted in compliance with the Rebuild Act, Act No. 2019-2.

2. Pursuant to the Act, the Town Council of the Town of Mulga, Alabama estimates that its anticipated allocation from the Rebuild Alabama Act fund for the first fiscal year will be approximately \$20,000, with increasing allocations for each fiscal year thereafter.

3. Pursuant to the Act, the Town anticipates expending funds received pursuant to the Act, in part or in whole, to fund any of the following listed projects:

- The maintenance, improvement, replacement, and construction of roads and bridges;
- Matching funds for federal road or bridge projects;
- Debt repayment for road and bridge projects; or
- Joint road and bridge projects with one or more municipalities and/or counties.

4. The Town Clerk is hereby authorized and instructed to post a copy of this Resolution as its Transportation Plan in a conspicuous place at the County Courthouse, the County Commission Office, the County Highway Department, the Town Hall, and also on the website of the Town of Mulga, Alabama.

5. The Town Clerk is hereby authorized and directed to establish a separate fund maintained by the Town of Mulga, Alabama for receipt and deposit of funds received pursuant to the Act, the proceeds of which shall be expended solely for the maintenance, improvement, replacement and construction of roads and bridges maintained by the Town and such other uses as are authorized by the Act.

6. This Resolution shall be retroactive to and effective as of August 31, 2019.
