ORDINANCE NO. 2023-01

AN ORDINANCE TO ADOPT THE SCHEDULE OF DEPOSITS AND SCHEDULE OF CHARGES & FEES FOR MULGA WATER & GAS.

WHEREAS, the Town Council of the Town of Mulga, Alabama (“the Town”) desires to amend its Schedule of Deposits and Schedule of Charges & Fees for the Town’s Water and Gas Department;


THEREFORE, BE IT ORDAINED by the Town Council of the Town of Mulga, Alabama, while in regular session on Tuesday, January 17, 2023, at 6:30 p.m., as follows:

Section 1. The Town Council hereby adopts and approves the fee list attached hereto as **Exhibit A** hereof, which sets for the Town’s Schedule of Deposits and Schedule of Charges & Fees. The Town’s previously adopted and approved Rate Tables and/or Rates and Fees schedules (by whatever name or names called) shall remain in full force and effect.


