We may can get the furnishings (tables and chairs) for the storm shelter at Sams.

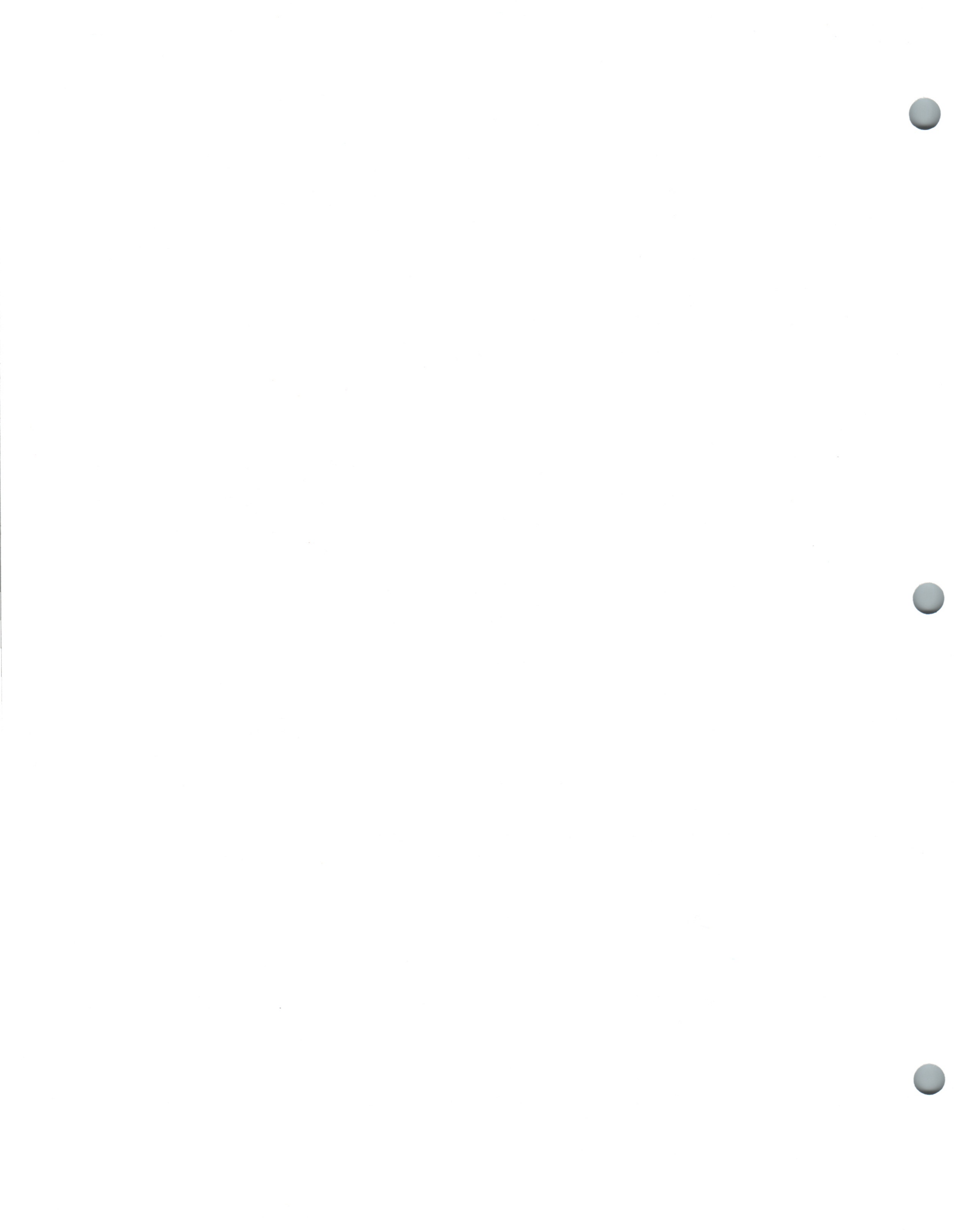
