

**TOWN OF MULGA, ALABAMA
MAYORAL PROCLAMATION**

WHEREAS, pursuant to Section 11-52-2 of the *Code of Alabama* (1975), the Town of Mulga, Alabama (the "Town"), adopted Ordinance No. 97-72 to establish a Planning Commission for the Town of Mulga, Alabama, known as the Town Planning Commission of Mulga, Alabama (the "Planning Commission");

WHEREAS, pursuant to Section 11-52-3 of the *Code of Alabama* (1975), the Mayor of the Town of Mulga, Alabama (the "Mayor"), is an elective officer of the Town and desires to appoint members to serve on the Planning Commission;

WHEREAS, prior to the promulgation of this Proclamation, the term has expired for all persons previously appointed to serve on the Planning Commission;

NOW, THEREFORE, BE IT PROCLAIMED by the Mayor of the Town of Mulga, Alabama, on this the 19th day of March, 2024, as follows:

A. I, W. Keith Varner, in my capacity as Mayor, shall serve as a member of the Planning Commission, for a term concurrent with my term as Mayor.

B. I hereby appoint Austin Lovelady, an administrative official of the Town, to serve as a member of the Planning Commission, for a term concurrent with my term as Mayor.

C. I hereby appoint the following individuals, who hold no other municipal offices, to serve as members of the Planning Commission:

- a. Jacob Presley, who shall serve for a one-year term or until the member's successor takes office, whichever occurs last;
- b. Ken Smith, who shall serve for a two-year term or until the member's successor takes office, whichever occurs last.
- c. James Smitherman, who shall serve for a three-year term or until the member's successor takes office, whichever occurs last.
- d. Jonathan Goodwin, who shall serve for a four-year term or until the member's successor takes office, whichever occurs last.
- e. Jason Smith, who shall serve for a five-year term or until the member's successor takes office, whichever occurs last.
- f. Richard Brown, who shall serve for a six-year term or until the member's successor takes office, whichever occurs last.

D. All members of the Planning Commission of Mulga, Alabama, shall serve without compensation.
