A RESOLUTION TO AUTHORIZE PAYMENT OF THE TOWN OF MULGA, ALABAMA'S APPROPRIATE MUNICIPAL OFFICIAL.

WHEREAS, on June 4, 2024, Mayor W. Keith Varner declared that John Williamson is designated as the Town of Mulga, Alabama (the "Town")'s "appropriate municipal official" to exercise the authority and perform the duties delegated by Sections 11-40-30 through 11-40-36 of the *Code of Alabama* (1975) and the Town's Ordinance Number 2017-03;

WHEREAS, the Town Council of the Town of Mulga, Alabama (the "Town Council") desires to authorize payment to John Williamson for services as the "appropriate municipal official";

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Mulga, Alabama, while in regular session on Tuesday, June 4, 2024, at 6:30 p.m. as follows:

- A. That the Town Council confirms that John Williamson is a "municipal official" of the Town for the purposes of the designation as the Town's "appropriate municipal official"; and
- B. That the Town Clerk is hereby authorized to make payment to John Williamson for services as the "appropriate municipal official" at the rate of \$75.00 per notice that such official may make as the "appropriate municipal official" to remedy an unsafe or dangerous condition pursuant to Section 11-40-31 of the *Code of Alabama* (1975) and the Town's Ordinance Number 2017-03.
