## **RESOLUTION NO. 2024-06**

A RESOLUTION DIRECTING THE PLACE WHERE THE TOWN CLERK SHALL DEPOSIT PUBLIC MONEY; DIRECTING THE MAYOR TO CONTINUE SAID ACCOUNTS: AND PROVIDING FOR RELATED ITEMS

**WHEREAS,** pursuant to Section 11-43-122 of the *Code of Alabama* (1975), the Town Council of the Town of Mulga, Alabama (the "Town Council") desires to provide for the deposit of public funds at ServisFirst Bank and Truist Bank;

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Mulga, Alabama, while in regular session on Tuesday, June 4<sup>th</sup>, 2024, at 6:30 p.m. as follows:

- A. Except for the accounts of Mulga Water & Gas Department, which are addressed in Paragraph B of this Resolution, for the accounts of the Town of Mulga, Alabama (the "Town"):
  - 1. The following is hereby authorized as the location where the Town shall deposit public money: ServisFirst Bank.
  - 2. The Mayor of the Town is hereby directed to establish bank accounts in the name of the Town of Mulga, Alabama, at ServisFirst Bank.
  - 3. The Mayor is further directed to cause the checkbooks, account statements, and such other documents related to the bank account, to be distributed to the Town Clerk.
  - 4. The Mayor is further directed to cause W. Keith Varner, Lelan R. Taylor, and Tabitha Galloway to be listed as joint signatories on all Town accounts, except for Mulga Water & Gas Department accounts, so that two signatures are required to cause the withdrawal of funds from the Town's account as provided for by law.
  - B. For the accounts of Mulga Water & Gas Department:
    - 1. The following are hereby authorized as the locations where the Town shall deposit public money for Mulga Water & Gas Department: Truist Bank and ServisFirst Bank.
    - 2. The Mayor of the Town is hereby directed to continue bank accounts in the name of the Town of Mulga, Alabama, d/b/a Mulga Water & Gas Department at Truist Bank and to establish bank accounts in the name of

the Town of Mulga, Alabama, d/b/a Mulga Water & Gas Department at ServisFirst Bank.

- 3. The Mayor is further directed to cause the checkbooks, account statements, and such other documents related to the bank account, to be distributed to the Town Clerk.
- 4. The Mayor is further directed to cause W. Keith Varner, Lelan R. Taylor, and Melissa Freeman to be listed as joint signatories on the Mulga Water & Gas Department accounts, so that two signatures are required to cause the withdrawal of funds from the Town's water and gas accounts as provided for by law.
