

**ORDINANCE NO. 2024-06**

**AN ORDINANCE AMENDING THE BUSINESS LICENSE  
CODE CONCERNING REAL ESTATE LICENSE FEES.**

**WHEREAS**, on the 16th day of October, 2007, the Town Council of the Town of Mulga, Alabama ("the Town Council") adopted Ordinance No. 2007-04, which sets forth the Business License Code of the Town of Mulga, Alabama, and which was thereafter amended by Ordinance No. 2014-02, Ordinance No. 2018-04, Ordinance No. 2022-01, and Ordinance No. 2023-02 (as amended, the "Business License Code");

**WHEREAS**, the Town Council wishes to amend Schedule "W" of the Business License Code to revise the calculation of fees for real estate business licenses;

**THEREFORE, BE IT ORDAINED** by the Town Council of the Town of Mulga, Alabama, while in regular session on Tuesday, October 1, 2024, at 6:30 p.m., as follows:

**Section 1.** Section 23, Schedule "W" of the Business License Code is hereby amended to reads as follows:

**Schedule "W" – Real Estate**

Each person, whether as principal or agent, engaged in the business of managing, buying, renting, selling or exchanging real estate, connected with such person's business, engaged directly in managing, buying, renting, selling or exchanging real estate in the Town of Mulga shall pay a base license fee of \$250.00.

Each real estate firm having a broker's license under the real estate laws of the state, having its principal place of business located in the Town of Mulga shall pay a base license fee of \$400.00.

Each person or company managing, renting, or leasing residential real estate or any related structure or improvement located thereon within the Town of Mulga shall pay an additional license fee based on gross receipts.

If gross receipts are:

Each person or company renting commercial real estate or any related structure or improvement located thereon within the Town of Mulga shall pay an additional license fee of 1% of gross annual rents, with a minimum additional license of \$200.00.


Hotels, motels, boardinghouses, and inns shall pay a license fee of 1% of gross annual rents for the next year preceding, with a minimum license of \$750.00.

**Section 2.** The provisions of this Ordinance are hereby declared to be severable. If any of these sections, provisions, sentences, clauses phrases, or parts is held to be unconstitutional or void, the remainder shall continue in full force and effect.

**Section 3.** This Ordinance shall become effective upon publication as required by law, but the fees set forth in Section 1 shall be imposed beginning on January 1, 2025.


