

TOWN COUNCIL OF THE TOWN OF MULGA, ALABAMA

RESOLUTION NO. 2025-02

A RESOLUTION PETITIONING THE LEGISLATURE OF ALABAMA TO AMEND SECTION 11-42-100.1 OF THE CODE OF ALABAMA (1975) TO ALLOW FOR THE REPRESENTATION OF AN ANNEXED MUNICIPALITY BY ALDERMEN ELECTED AT LARGE BY THE ANNEXING MUNICIPALITY.

WHEREAS, the Town of Mulga, Alabama (“Mulga”), and the Town of Maytown, Alabama (“Maytown”), desire to consolidate by having Mulga annex Maytown;

WHEREAS, pursuant to Section 11-42-100.1 of the *Code of Alabama* (1975), after an election approving the consolidation, Maytown would need to “be divided into wards or districts or annexed to wards or districts already established”;

WHEREAS, pursuant to Section 11-43-2 of the *Code of Alabama* (1975), Mulga has adopted Ordinance No. 2024-09 determining to elect council members at large beginning with the next municipal term;

WHEREAS, Mulga desires to amend Section 11-42-100.1 to allow for the representation of an annexed municipality by aldermen elected at large by the annexing municipality;

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Mulga, Alabama, while in regular session on Tuesday, January 21, 2025, at 6:30 p.m. as follows:

A. The Town Council expresses its support for amending Section 11-42-100.1 of the *Code of Alabama* (1975) to allow consolidated municipalities to allow for the representation of an annexed municipality by aldermen elected at large by the annexing municipality and petitions the Legislature of Alabama to enact legislation accomplishing the same.

B. With utmost respect for its legislative counterparts and with appreciation for their consideration of this matter, the Town Council directs the Mayor to present a copy of this Resolution and the accompanying legislation to the Town’s representatives and senators in the Legislature of Alabama and any other person necessary in effort to have the amendment passed into law.
