Pre-Council meeting called to order at 6:12 p.m. by Mayor W. Keith Varner at Mulga Town Hall.

Council members present Jeremy Davis, Lelan Taylor and Rachel Davis.

Council members absent Brenda Zinnerman and Lisa Armstrong.

Mayor: We are going to ask Mulga Baptist Church if we can use their parking lot. There will be parking in the field and we'll ask the methodist church if we can use their parking lot.

Ben Goldman: I will send you a vendor form that you can use for the vendors.

There is no state law on shooting outside. An officer has to witness it, themselves.

If we had a city ordinance, we'd be wasting our time because there is no one to enforce it.

The sheriff's department makes it clear they will not enforce city ordinances. We are not going to give up. We are still looking at solutions.

Ben: I have been looking into grants that could help with this. Giving the sense of urgency, the council could authorize the mayor to take on a grant writer. They will be able to search out and find grants to help with this situation.

The newly purchased engine is getting new tools like bolt cutters, nozzles, etc.

Mayor: How many volunteers have recently joined?

Dalton Vildibill: The roster has about 20 on it. But, many of them are inactive. We are trying to reach new volunteers.

How do we get the website changed? It still shows the old chief's name.

Mayor: Get with us in the office and we can get it changed.
