RESOLUTION NO. 2025-12

**A RESOLUTION REPEALING RESOLUTION NO. 2025-11
AND REJECTING THE SOLE BIDDER'S RESPONSE TO
THE INVITATION TO BID FOR THE FURNISHMENT OF
ROLL-OFF EQUIPMENT AND AUTHORIZING THE
FURNISHMENT OF ROLL-OFF EQUIPMENT BY
NEGOTIATION THROUGH THE RECEIPT OF INFORMAL
BIDS.**

WHEREAS, the Town of Mulga, Alabama (the "Town"), adopted Resolution No. 2025-09 at a regularly scheduled meeting on May 15, 2025, authorizing the Mayor to solicit competitive bids for the furnishment of roll-off equipment;

WHEREAS, notice of the solicitation of competitive bids was given as required by law;

WHEREAS, the bid responses was read aloud in an open public forum at Mulga Town Hall on June 3, 2025, at 5:00 p.m.;

WHEREAS, only one bidder, Trailer World, responded to the invitation to bid;

WHEREAS, on June 3, 2025, the Town adopted Resolution No. 2025-11 accepting the bid and authorizing the furnishment of roll-off equipment by negotiation provided that the negotiated price is lower than the bid price;

WHEREAS, the Town subsequently learned that the bid received by the Town was not responsive and should've been rejected;

WHEREAS, pursuant to Section 41-16-50 of the *Code of Alabama* (1975), if no bids are received at the time stated in the advertisement for bids, the awarding authority may negotiate through the receipt of informal bids not subject to the requirements of this article;

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Mulga, Alabama, while in regular session on Tuesday, July 1, 2025, at 6:00 p.m. as follows:

A. The Town Council hereby repeals Resolution No. 2025-11.

B. The Town Council hereby finds that Trailer World's bid received in response to the invitation to bid for the furnishment of roll-off equipment is non-responsive and rejects the sole bid received.


C. Pursuant to Section 41-16-50(b) of the *Code of Alabama* (1975), the Mayor is hereby authorized to negotiate, through the receipt of informal bids, for the furnishment of roll-off equipment as contemplated by the bid solicitation.

D. The Mayor, Clerk, and Town Attorney are hereby authorized to do all things necessary to complete the purchase authorized by this Resolution, including for the Mayor to execute any documentation required or expend any sums necessary to complete the purchase.


