## **RESOLUTION NO. 2025-25**

A RESOLUTION ACCEPTING THE BIDS RECEIVED FOR INSTALLATION SERVICES FOR THE MULGA WATER SYSTEM DWSRF IMPROVEMENT PROJECT AND AUTHORIZING THE MAYOR TO CONTRACT WITH THE LOWEST, RESPONSIBLE BIDDER.

- WHEREAS, the Town of Mulga, Alabama (the "Town"), owns and operates its own municipal water and gas systems ("Mulga Water & Gas") (collectively with the Town, "Mulga");
- WHEREAS, Mulga Water & Gas serves Town residents and citizens in neighboring communities;
- **WHEREAS,** a few of Mulga's lines are causing ongoing maintenance issues due to being undersized and aged;
- **WHEREAS,** Mulga desires to remedy this issue and improve water quality pressure to its customers by constructing larger lines (the "Project");
- **WHEREAS,** the Town previously adopted Resolution No. 2023-22 at a regularly scheduled meeting on December 5, 2023, authorizing the Project and accepting grant funding for the Project from the Alabama Department of Environmental Management ("ADEM");
- **WHEREAS**, Mulga solicited bids for the installation of larger lines in furtherance of the Project (the "Work");
- **WHEREAS,** Mulga received a number of bid responses, which were opened publicly and read aloud at Mulga Town Hall on June 30, 2025, at 10:00 a.m., which was the advertised place and time;
- **WHEREAS,** Mulga desires to award a contract for the Work to the lowest, responsible bidder;
- **NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Mulga, Alabama, while in regular session on Tuesday, August 5, 2025, at 6:00 p.m. as follows:
- A. The bids received on June 30, 2025, for a contract related to the installation of the Project, are hereby accepted.
- B. The Town Council hereby finds and determines that the lowest, responsible bidder for the Project is Global Construction, LLC ("Awardee"), and the contract related to the Project shall be awarded to Awardee in the total amount of \$352,072.10, contingent upon the execution of a contract in a form to be approved by the Mayor and Town Attorney.

- C. The Mayor is hereby authorized to waive any irregularities in the bid that he deems prudent and to negotiate contract terms that are at least as favorable to the Town as set forth in Awardee's proposal.
- D. The Mayor, Town Clerk, and Town Attorney are hereby authorized to do all things necessary in furtherance of this Resolution.
  - E. This Resolution shall become effective upon its adoption as provided by law.
