A RESOLUTION EXTENDING THE DEADLINE FOR THE DEMOLITION OF A BUILDING OR STRUCTURE LOCATED AT 204 FOREST AVENUE, MULGA, ALABAMA, PARCEL ID NO. 21-00-17-4-004-009.000, IN COMPLIANCE WITH SECTION 8F OF ORDINANCE NUMBER 2017-03 OF THE TOWN OF MULGA, ALABAMA

WHEREAS, a Public Hearing was held on December 17, 2024, at 6:30 p.m. and after due deliberation the Town Council of the Town of Mulga, Alabama found that the structure standing at 204 Forest Avenue, Mulga, Alabama, Parcel ID No. 21-00-17-4-004-009.000 was unsafe to the extent of becoming a public nuisance to the citizens of Town of Mulga, Alabama and was due to be condemned and demolished in compliance with Sections 11-40-30 through 11-40-36 and Sections 11-53B-1 through 11-53B-16, inclusive, of the *Code of Alabama* (1975), and Ordinance Number 2017-03 of the Town of Mulga, Alabama;

WHEREAS, the demolition cannot be completed on or before the deadline;

WHEREAS, Benny McKenzie, the Building Inspector for Mulga, Alabama made a report to the Town Council of Mulga, Alabama recommending an extension of the time for demolition for a reasonable period of time as set by the Town Council of the Town of Mulga, Alabama;

WHEREAS, on July 1st, 2025, a public hearing was held before the Town Council to determine whether to extend the time for demolition;

WHEREAS, subsequently following said public hearing, the Town adopted Resolution No. 2025-16 extending the deadline for demolition to August 14, 2025;

WHEREAS, the deadline to complete demolition of the structure has passed;

WHEREAS, the Town failed to complete demolition within the set time;

WHEREAS, the Town desires to extend the deadline again as to allow the Town time to demolish the structure;
